**Written consent to publish photos, films and personal data on the state

Please note that the publication will take place absolutely voluntarily and that personal data will not be published without your consent.

We therefore ask you to sign this required declaration of consent:

I / we entitle the **State Academy** to take pictures of persons in relation to seminars or to take pictures of or make films of events at the state academy which may be published in print products /brochures, annual reports), newspapers and on the state academy's homepage.

In some cases the person's name and function (e.g. academy instructor / consultant) might be published, for example when a special activity of a person (chairing of the seminar / lecture, etc.) is to be pointed out.

Personal data, pictures and graphs are *saved* on the state academy's server.

It is intended to publish personal data as follows:

In these forms of publications my data may be used as follows:

- pictures of persons in a group of persons without naming (e.g. a group picture)
- pictures of persons including naming (e.g. lecturers)
- naming (e.g. persons making reports of seminars, projects, etc.)
- pictures of persons with names (e.g. of homepage contact or reports about projects or seminars)

Besides there may be:

- Shootings in relation to a lecture

Indication of private data protection:

Due to the intended use in the internet the personal pictures and/or names as well as any published personal information can be accessed and saved worldwide. Therefore corresponding data can be found and tracked with so called "search engines". It can also not be ruled out that other people or enterprises connect these data with other data available on the internet which can result in generating a personality profile, changing the data or using them for other purposes.

I, the signatory, consent to generate accessibility of single images. This consent can be withdrawn at any time in future. However, this consent cannot be withdrawn in the case of imagining several persons unless the interests of one of the portrayed persons are not balanced. In case of disclaimer/disconfirmation single images must no longer be used for the purposes mentioned above and must immediately be deleted from the relevant internet offers. The consent is valid unlimited as long as is not disclaimed. The consent is voluntary; in case of refusing the consent no disadvantages will occur.
